Lasting Impacts: Ta'Niya's Story



In April 2011, doctors concluded that her head growth was not within normal limits and was growing too rapidly for her age. After an emergency MRI and an appointment with a neurologist, it was determined that she had excessive amounts of cerebrospinal fluid around her brain and all four ventricles were blocked with fluid. Ta'Niya had surgery the next morning to have a ventriculoperitoneal (VP) shunt placed to relieve pressure from her brain caused by the fluid accumulation. "That was the scariest thing I have ever experienced," Kanika said. "She was only nine months old and having brain surgery." Ta'Niya came out of surgery rolling over right away, which is something she had never been able to do prior to surgery.

Another hurdle came when Ta'Niya was three years old. At her very first visit to Shriners Hospital for Children, they were told that Ta'Niya possibly had cerebral palsy and that she would never be able to walk because the bones in her ankles were deteriorating. The medical team at Shriners recommended that they break both of her ankles and reset them. Kanika did not want Ta'Niya to have to go through another surgery and sought out another option. Ta'Niya soon received bilateral DAFOs (Dynamic Ankle Foot Orthotics) to assist with balance, coordination and body symmetry.

Ta'Niya was referred to the Achievement Academy charter school in August 2013 when she was three years old to help with her developmental delays. She started out using a walker but through physical therapy and assistive equipment, Ta'Niya is now walking independently, skipping, doing jumping jacks — and no longer needs surgery! Ta'Niya is highly motivated to be mobile and doesn't allow her motor difficulties to stop her from accessing the school environment. "What she has overcome since starting Achievement Academy is just remarkable," says Ta'Niya's mom.

Ta'Niya's teacher for the past two years at Achievement Academy has been Susan Shipe. Ms. Susan said that at first she was hesitant about recommending mainstream kindergarten for Ta'Niya, but by the end of last year she knew she could make it. "I'm impressed Ta'Niya has done so well. I watched her growth last year and decided we needed to push her even harder," Ms. Susan said. "Ta'Niya is challenged in every aspect physically, socially and mentally at Achievement Academy. Ta'Niya's determination and confidence have helped her succeed. She doesn't realize she has any limitations."

This Fall, Ta'Niya will begin kindergarten in a mainstream class. Kanika is so thankful for Achievement Academy and how it has helped Ta'Niya with her development. Wanting to "pay it forward," Kanika recently made a donation to the school to purchase a Kindle with all its accessories for Ta'Niya's classroom. "Everyone at Achievement Academy has gone above and beyond and it is greatly appreciated," Kanika said. "I'm just completely satisfied with the advancement she's made. It's because of Achievement Academy that she's where she is today."

Lasting Impacts: Katie's Story

My daughter, Katie, has been connected to the Achievement Academy since before she was born. You see, I was a teacher in one of our Lakeland classrooms and, when I became pregnant, everyone at the school was excited for Katie to arrive. In fact, Katie was going to be featured in a video for the physical therapy department showing typical reflexes and development of an infant. In November 2006, Katie made her appearance in a typical birth with no issues. She was full-term; everything seemed fine.

Just a few days after her birth, Katie began wheezing and sounding congested and we thought she had a cold. I brought her in to be video-taped by the Physical Therapy/Birth to Three departments and one of the physical therapists immediately noticed that Katie was not having the typical reflexes right after birth. I took her back to the pediatrician and he confirmed that she had a heart murmur but assured us that many children have them and made an appointment for a cardiologist.

At 17 days old, we discovered that Katie had an enlarged heart and was in congestive heart failure. She was rushed to the Pediatric ICU in Lakeland and treatment began. At 11 weeks old, she had open heart surgery to repair the holes that were causing such stress to her body. She was 5 pounds at 11 weeks old, weak and frail. Upon returning home, she immediately became enrolled with Achievement Academy's Birth to Three Program and later attended the charter school for several years receiving physical and speech therapy along with wonderful educational instruction for her developmental delays.


Today, Katie is in 3rd grade and is in the STEM program which is academically accelerated curriculum. She was one of only seven students in 2nd grade to receive all A's for the entire school year and, in fact, has received all A's since Kindergarten. She was dismissed from the speech program for Polk County Schools during her 1st grade school year. She still has vision and hearing issues that she will deal with her whole life and needs monitoring by a cardiologist but we are so incredibly proud of how far she has come.

Katie is blessed to come from a loving home with supportive people in her life to push her to succeed but that alone is not what has built this success story. Achievement Academy made the difference for our little girl. The time and attention given to her over the years by the early interventionists, teachers and therapists have brought her to where she is today. Had Achievement Academy not been a part of our lives, I know that Katie would not be where she is today. Our lives have forever been changed by this amazing organization and our community is stronger because of their work to make children's lives better.
