Violations Comments

Violation #2. Playground

One of the swings was observed to have chains that are starting to rust. These must be repaired or replaced so that there is no rusted surface.

CODE REFERENCE: Playgrounds and Athletic Equipment. 6A-2.0040(2)(a)(c). Playgrounds shall be constructed & maintained to permit maximum utilization of sites with elimination of sanitary & health hazards including mudholes, fragments of glass, stone & similar obstructions. 468.2.2. Playground & equipment shall be safe, structurally sound, vermin proof, & shall not have jagged or sharp projections. Playground equipment shall be anchored to suitable foundations. Mats, wood chips, or sand shall be used under climbing equipment, slides, & swings.

Violation #5. Maintenance & Repair

A ceiling tile around an indoor swing that was hanging from ceiling in one of the classrooms was observed to be bulging down from the ceiling. Staff stated this happens sometimes from the motion of the swing. This must be repaired so that it cannot slip out when swing is used. (If this is not possible, swing must be removed).

CODE REFERENCE: Maintenance & Repair. 6A-2.0040(3)(b)(c). Buildings shall be kept clean & in good repair, free from hazardous conditions, such as loose or broken floor tiles & boards; loose moldings; loose hanging fixtures, pipes, electric wires; & broken plaster. Furnishings & equipment shall be kept clean & in good repair, free of missing parts & sharp edges.
