General Comments

Mrs. Stacy s room was looked at regarding a parent complaint (complaint #53-99-420242). Complainant stated that she had heard that flood-waters from Hurricane Milton as well as sewage water had flooded into the room. Complainant was concerned that the carpet should be replaced and that it had only been cleaned. Complainant stated that there was a mold-like smell in the building.

Staff stated that this room had water soaked into the carpet from the hurricane, which was observed to cause some damage to desk and door at back corner of room. Staff stated that a carpet cleaning company (Heaven s Best) came out and dried the room, taking out the water and shampooing the carpet. Antimicrobial cleaners were used and dehumidifiers were run for over a week. The last one was taken out today. Staff stated that the company pulled carpet up and felt behind baseboards and the baseboards were not wet.

A musty smell was observed in the building but no mold-like substance or wet carpet. It is recommended to keep ventilation at a maximum by running air conditioner fans overnight and during the day, and bringing in additional fans to affected rooms to continue to ventilate until the smell is gone.
